The American Recovery and Reinvestment Act of 2009 required the distribution of an economic stimulus package of nearly \$800 billion to recipients throughout the country. Using EPA's Central Data Exchange (CDX) as the technology platform, CGI developed and managed the FederalReporting.gov website to capture external recipient reporting on funds received, place of performance, and jobs created. Leveraging an existing platform to exchange data between the federal government and other federal and state agencies and industries avoided significant system development costs for federal agencies and simplified the recipient's reporting process.

FederalReporting.gov was the first use of government-wide data standards for reporting and provided machine-readable data for analysis. The data allowed the Recovery and Accountability Transparency Board (RATB) to successfully provide transparency for federal spending down to the Congressional District and zip code level and leverage the information to provide a high degree of compliance and accountability. CGI and the RATB met an extremely aggressive timeline and experiences gained by the successful implementation of FederalReporting.gov and other programs led to Congress passing the DATA Act in 2014.

FUNDS DISBURSEMENT AND TRACKING

Following Hurricanes Sandy (2012) and Maria (2017), CGI designed and operated the integrated solution to manage and track more than \$20B of disbursements, providing full visibility into how federal funds were spent. A robust digital technology solution helped ensure the proper disbursement of large amounts of federal dollars to quickly help residents recover and rebuild, as well as meet program requirements, including HUD and HUD-OIG. RECOVERY BOARD OUTCOMES


CGI's FederalReporting.gov site was used to support nearly 3,200 audits, inspections and reviews by Inspectors General in all agencies receiving funds. Recovery Board-related findings resulted in:

- 1,665 convictions, pleas and judgments.
- \$157 million in recoveries, forfeitures, seizures and estimated savings.
- Less than 1% total funds lost to waste, fraud or abuse.

CGI designed and built Open Payments for the Centers for Medicare and Medicaid Services (CMS) as a centralized portal to enable consumers to view a provider's financial relationships and to make informed healthcare decisions. Open Payments publishes large amounts of data within short, federally-mandated timeframes. The system also provides researchers at CMS with a dataset for performing analysis and identifying emerging trends. Since inception, Open Payments has published 65 million records, representing \$48.7 billion in payments.
