



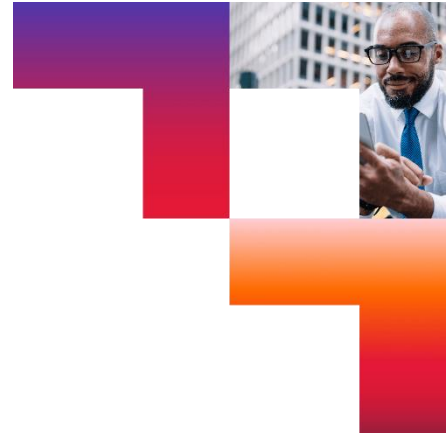

## Fedwire processing

- **Multi-channel origination** via manual capture, recurring templates, system integration or clearing gateways (e.g., SWIFT)
- **Inherent interoperability** with message parsing, formatting and validations rationalized into a native ISO 20022 payment object
- **Configurable workflows** constructed by sequencing standard payment processing services (e.g., enrich, validate, duplicate checks, OFAC/fraud, routing, stop checks, fees, booking, etc.)
- **Payment enrichment/validation/routing** based on Federal Reserve Board or Accuity reference data in conjunction with user-defined business rules
- **Automated matching**, processing and responses for:
  - Returns and return requests
  - Drawdowns and drawdown requests/refusals
- **Automated end-of-day and start-of-day** processing (e.g., link control, liquidity, sequence number resets, etc.)
- **Modular workflows** that provide granular, flexible automation control to reduce manual intervention and maximize straight-through processing rates
- **Automated transformation of legacy formats** to and/or from down/upstream applications

- Granular queue-by-queue link control, cutoff scaffolding, gap detection and retrievals
